A Note From the Chair

In this, our final newsletter of 2022, I wish you all a Happy Christmas and New Year and hope you get to spend time with loved ones over the upcoming holiday period. The past twelve months, as always, have been very busy and productive for the Association. Our membership numbers have continued to grow steadily, which is great, and as we come to the year's end, I extend a warm welcome to all our new members in particular. I also want to thank our Board, Council, SIGs, Committees, and members of various groups, as well as our fantastic staff team, for all their dedicated work in 2022. Since our previous newsletter, a range of events have been held as part of our ongoing and extensive CPD programme. Our 50th anniversary



celebration and national social work conference, on 20 and 21 October respectively, gave us an opportunity to reflect on some of the key issues facing social work, past, present and future. We launched our new Position Paper on Adult Safeguarding at our IASW event on National Adult Safeguarding Day, Friday 11 November, which was a great success, including as it did a really positive input from Minister of State Anne Rabbitte TD, along with the other excellent inputs. On 25 November, we launched the Position Paper on Adult Mental Health and Housing, prepared under the auspices of our SWAMH Special Interest Group, at the SWAMH annual conference, again with a range of high-quality inputs.

The review of IASW's structure and governance is currently being completed with the IASW Board due to consider the review findings and recommendations at a special Board meeting this month. I look forward to receiving the review report and to actioning its findings in cooperation with the Board, staff team, our SIGs, committees and associate groups. Also this month, we will launch a campaign to press for a greater strategic focus by government on the serious issues facing social work, and specifically to address the challenges of attracting more people to the profession, as well as addressing the recruitment and retention problems in the sector. It is great to be finishing the current year on a high in terms of energy and activity, and looking forward to continuing our work as the strong, ethical and independent voice of social work and social workers in Ireland. That voice is further strengthened by our connections with colleagues in other jurisdictions. I had the honour and privilege recently of meeting the President of the fledgling Ukrainian National Association of Social Workers — Yana Melnychuk —and learning directly about the challenges she and her colleagues face. Early in the New Year, we will be announcing details of an exciting new and reciprocal associate membership scheme with our BASW-NI colleagues. Additionally, in the past few weeks we have launched our IASW LinkedIn page, which will be another IASW presence on social media and way of connecting with

members, colleagues and other partners. I encourage you to connect with us through LinkedIn and our other social media channels. As 2022 draws to a close, I look forward to working with you all, in the days, weeks and months ahead, to represent the social work profession and social workers – stronger together for social change.

Accelerating Inequalities, Impossible Choices: Exploring Anti-Poverty Practice in Social Work



This year's IASW National Social Work Conference 2022 Accelerating Inequalities, Impossible Choices: Exploring Anti-Poverty Practice in Social Work put the focus firmly on poverty. Poverty has recently been described as the wallpaper of practice, "too big to tackle and too familiar to notice" (Morris et al 2018) and in the context of the growing cost of living crisis, it's crucial that our social work practice sees and names poverty and its impacts on those we work with. Activists from ATD Ireland set the tone for the day, providing insight and reflections on their experiences of living in poverty as well as sharing learning with conference participants. As the first in person IASW conference since 2019, there was great energy as members, guests and invited speakers gathered to listen, share and reflect on ways of embedding anti-poverty practice into the work we do.
