Priority will be given to proposals that meet either one of the objectives of the IASW Strategic Plan or align with one or more priorities of the HSCP Office. CPD proposals that align with the HSCP Office CPD priorities will inform the CPD event funding applications made by the IASW Professional Development Coordinator to the HSCP Office and will be subject to the funding criteria for that office. Please refer to Appendix 1 before continuing. A condition of event funding granted by the HSE is that event participants must work in the publicly funded healthcare service.

CRITERIA FOR CONTINUING PROFESSIONAL DEVELOPMENT ACTIVITIES (National HSCP Office, HSE 2021)

Desired outcomes

CPD activities organised and managed by the professional body should:

- Ensure professionals are enabled to maintain and develop skills, competence and standards in the practice of their own profession in order to deliver high quality and safe services.
- Facilitate development of knowledge on evidence based practice and scientifically proven developments within the respective professions.
- Contribute to changing practice as proposed in the Models of Care recommended by the HSE's National Clinical Programmes and Integrated Care Programmes e.g. Older Persons, Chronic Disease Prevention and Management.
- Learning/Training will facilitate implementation of Sláintecare goals and principles e.g. supporting care closer to home, supporting avoidable hospital admissions, health prevention and promotion.
- Learning/Training will contribute to meet the needs of the service while taking into account individual development needs.
