Dear Minister Donnelly,

We, the below signed, are writing to outline our concerns that the health impact of the Covid-19 pandemic, on people living with dementia and their family carers, is not being adequately considered and that the unique needs of this extremely vulnerable group of people are not in any way part of current discussions and debate.

The recently published report "The impact of COVID-19 pandemic on people living with dementia in Ireland", by Niamh Hennelly and Professor Suzanne Cahill, describes the complex and problematic situation in Ireland for people living with dementia and their family carers. The report concludes that "policy and practice needs to focus on how people living with dementia and their informal and formal carers can be optimally supported".

We are deeply concerned that dementia has not been included specifically in data collection related to Covid-19 mortality or in the public messaging being issued. We are also alarmed at the lack of emphasis placed on the complex needs of those impacted by dementia, whether in the community or in residential settings.

People with dementia and their family carers have been rendered invisible during this crisis, and we are calling on you to address this invisibility as we move beyond the "emergency" planning for Covid-19. We are writing to ask you to ensure that dementia is given the consideration it warrants and deserves in terms of public health policy, research into its impact and future planning with regards to Covid-19 and to prioritise the issuing of guidelines for the reopening of services and supports for people and their families.

We hope that you will give these issues the consideration they deserve.
