IASW Social Work During Covid-19 Survey



Findings from the first data set, which was collected during lockdown, are available <u>here.</u> Some of the key messages so far are:

- The impact of lockdown restrictions on direct work emerged as the biggest challenge, highlighting the significance social workers place on building relationships through face to face contact.
- Workplace challenges were also high on the agenda as social workers dealt with the challenges associated with rapidly changing and new work practices (40%) and issues related to their employer response (30%).
- The biggest worry for social workers (one in three) during lockdown was the impact of lockdown restrictions and the closure of supports and services on the children, families, and individuals they worked with.
- A third of social workers worried about how best to provide a high-quality social work service safely during lockdown as well as worrying about how to meet the increased needs and demands when services resume.

Findings from the second data set collected during Phase 1 of Easing Lockdown (204 responses) will be available in the next few weeks. <u>Data collection has closed.</u>

IASW Online Events and Training April - July 2020

IASW Past Events

Using an Attachment and Trauma Informed Perspective in Social Work with Children

This online training was delivered to IASW members via Zoom by Aoife Bairéad, who specialises in trauma and attachment. It comprised of two days and was offered on the 6th and 20th of April, 17th of April and 1st of May, and 8th and 22nd of May. This course incorporated practical skills for direct work with children. The learning goals were:

- To develop a basic understanding of how trauma impacts children's development.
- To recognise and respond to behaviours relating to developmental trauma in children.
- To explore how to incorporate trauma focused work into work with children.

Getting Started with Online Working

Aoife Bairead kindly offered to share her knowledge about working online, to help some social workers who are starting to use this forum. She did a 45 minute tutorial aiming to those who provide supervision and/or to facilitate peer support. It was offered to IASW members on the 7th of April via Zoom. We thank Aoife for sharing what she knows as a way of supporting social workers to get started with online working.

Talktime Online

The the CPD Coordinator, Clíona Muprhy and Board member, Hilda Loughran, have sought to share the IASW Zoom account more widely with IASW social work members. The aim has been to hear how they have been coping and adapting to the different ways of working at this time, supporting each other and sharing ideas and issues. It has taken place on the 16th, 22nd and 29th of April, 7th, 14th and 21st of May and 25th of June. On the 15th of July, a Talktime for Social Workers in Mental Health was facilitated by Linda Curran and Sinead McKenna, Chair and Vice-Chair of Social Workers in Adult Mental Health (SWAMH) Special Interest Group.

Resilience - Finding Spaces

This three-day online course facilitated by Niamh Bruce is being offered through the 14th, 21st and 28th of July. Its purpose is to introduce social workers to mindfulness and meditation practices. Those practices can act as genuine supports in the art of building resilience, enhancing listening and communication skills and sustaining overall wellness, intertwining them into existing routines. The course includes discussion, theory, and experience of practice to nourish and replenish your body and mind.
