


IASW NEWSLETTER September 2020



The IASW Board is pleased to advise you that the process of revising the Code of Ethics and the Code of Practice is now complete. The revisions to the codes were endorsed by the members at our AGM this year. The Board would like to thank sincerely all of the members who contributed to the process.

These codes are, of course, living documents and therefore they are subject to review from time to time. The last revision took place in 2011. The latest editions are designed to meet our current needs and challenges and include, for example, reference to the climate emergency and to social media. Principles of social justice, human rights and respect for persons remain at their core. We hope that they will be of benefit to you in your practice!

IASW Social Work During Covid-19 Survey



The second report on the IASW Social Work During Covid-19 Ongoing Survey has been uploaded to the IASW web page (see link below). It presents the findings on the data collected during the first phase of Reopening Ireland/Easing Lockdown Restrictions (19th May – 8th June). 204 responses were received, with social workers in Children and Families being the largest group of respondents, comprising 34% of responses. Some of the key findings were:

- Social workers had more worries as Ireland began Phase 1 of Easing Lockdown Restrictions than they experienced during lockdown.
- The biggest worry for social workers (46%) was how to provide an adequate social work service. 33% said they were worried about their clients.
- The challenges for social workers had also increased.
- Social workers were provided with either the same or less support from their employers than they were during lockdown.

We would like to thank all of those who took the time to complete the survey and share experiences and learning with the IASW and beyond.

IASW Past Events

The Assisted Decision Making (Capacity) Act 2015

This training which started on the 21st of September, will be delivered using a blended approach. Participants have been invited to complete a 10 hour online learning course over a four week period until the 20th of October. Secondly, the participants will be invited to partake in a 3 hour Zoom meeting. This course will provide participants with the knowledge and skills required to implement the Assisted Decision Making (Capacity) Act into everyday practice. As this legislation is a key element in the ratification of the UN Convention on the Rights of Persons with Disabilities, it also aims to support the learner to develop an understanding of the Convention. The course is facilitated by Josephine McLoughlin who has over 20 years' experience as a Social Care Leader in the social care sector.

Talktime Online

There have been three Talktime sessions in the last couple of months. A Talktime on Reflective Practice hosted by Dr Carmel Halton on the 20th of August and two Talktime on Anti-Racist Practice in Social Work co-hosted by Colletta Dalikeni and Evelyn Oboh, one on the 26th of August and another one, on the 23rd of September. For a few months, the CPD Coordinator, Clíona Muprhy and Board member, Hilda Loughran, have been using Zoom to bring together social workers and discuss how they are getting on, and how they are coping and adapting to the different ways of working. All the sessions have been very well attended and have worked as a way of supporting each other and sharing issues and ideas.
